

# Accreditation School Profile

## Sarnia Christian School

**October • 2010**

The boards of the Sarnia Christian School and Canadian Hallmarks Institute (CHI) are pleased to publish this *Accreditation Profile* as a public service promoting independent faith-based education in the greater Sarnia/Lambton area. The format of this profile follows CHI standards: The contents of this profile were developed using local information obtained as part of the successful accreditation review.

### 1. Mission:

The official mission of the school is:

*As a Christian school in partnership with families and community we:*

- *Deliver an education, which integrates faith and learning within a safe environment.*
- *Challenge students to discover their gifts and use them to serve God and Community.*
- *Equip students with the skills and discernment required to interact with contemporary culture.*

### 2. Governance:

Sarnia Christian School is owned by the Lambton Christian School Society and operated on its behalf by an elected board of 10 directors. The Lambton Christian School Society is a registered charity (#129904264RR0001) and membership in the society is open to all adults who meet the criteria.

### 3. Community Demographics of School

- a) The families supporting Sarnia Christian School come from a wide range of socio-economic backgrounds. A total of 35 different occupations are represented as well as a large economic range, from needy to wealthy families.
- b) The general statistics for Sarnia/Lambton County taken from Stats Canada Reports (2006), which provide the following:
 

● Average (full-time income all families)	\$69,731
● Average (income single/parent families)	\$35,881

## 4. Admission Policies for Students

- a) The Sarnia Christian School Board has adopted a policy of non-discrimination in support of the Ontario Human Rights Code. In promoting its distinctive Christian character, the policy requires that students should:
  - be able to benefit from the programs offered and that parents should
  - declare their (his/her) support of the school's religious identity as evident in official documents.
- b) The student body is 100% composed of Canadian citizens.

## 5. Faculty

- a) Sarnia Christian School has 5 full-time and 3 part-time teaching staff, 100% of whom have the Ontario Teacher's Certificate, 88% hold the Christian Teacher's Certificate and 88% hold both the Ontario Teacher's Certificate and the Christian Teacher's Certificate.
- b) The average teaching experience of the staff is 9 years (full time equivalent). The board requires an annual program of professional development for all teachers.
- c) The pupil-teacher ratio (PTR) is 15:1 for 2010/11.

## 6. Student Achievement

Sarnia Christian School has a student body of 87 and a complete JK-8 program. The faculty follows a defined evaluation program to monitor the academic and social progress of each student.

- a) Basic Skills - The school participates in the Ontario Alliance of Christian Schools (OACS) student assessment program on an annual basis. In 2008, Grades 3 - 8 participated in the Canadian Tests of Basic Skills (CTBS) with outstanding results.

- b) Literacy Test from Province - The school participates in the elementary provincial tests sponsored by the Education Quality and Accountability Office (EQAO).
- c) Sarnia Christian School graduates attend London District Christian High School where 100% of students passed the Provincial Literacy Test, St. Christopher, Northern Collegiate and St. Clair Highschool.

- d) Other significant awards given are Athletic, Long Distance Running, Track and Field, Geography, Valedictorian, Academic.

## 7. Programs of Study

- a) Sarnia Christian School offers a complete range of academic programs for all grades. The curriculum follows the outline developed by the OACS. This design follows the official Ministry of Education curriculum in content requirements.
- b) The board and faculty are committed to the integration of Christian perspectives throughout the entire program of studies.
- c) Sarnia Christian School has a special education resource program and a special needs program. It provides technological studies at many grade levels to ensure that students acquire computer literacy before graduation.

## 8. Finances

- a) Sarnia Christian School obtains its income from several sources, notably:
- 73% from tuition;
  - 6% from donations;
  - 0% from government grants;
  - 9% from fundraising events;
  - 12% other
- b) 2010/2011 Year the tuition rate is \$3,818 - 13,186 (family rate is based on grade and number of children).
- c) For families experiencing temporary financial hardship, the board provides assistance in the form of needs-based grants, church grant, and/or volunteer grant.
- d) The official budget is approved each November at a general membership meeting. The budget expenditures are as follows:

## 9. Membership

Sarnia Christian School is part of a large family of schools known as the Ontario Alliance of Christian Schools (OACS). This provincial organization provides general policy guidelines on all matters relevant to operating a school in Ontario. Sarnia Christian School is also a member of Christian Schools Canada (CSC) and Christian Schools International (CSI). The school is registered as a private school with the Ontario Ministry of Education and submits annual reports as required by law.

## 10. Testimonials
